



Greetings from Council for Leather Exports!

At the outset let me introduce to you the Council for Leather Exports popularly known as CLE.

Council for Leather Exports is an apex organisation for promoting Leather and Footwear Exports from India and work under the aegis of Department of Commerce, Ministry of Commerce & Industries, Govt of India. It has 5 regional offices at Chennai, Mumbai, Kolkata, Kanpur and Delhi and has head office in Chennai. Besides, CLE is also having two extension office viz. Agra and Jalandhar which comes under northern region. For the sake of convenience of administration and promotion of leather and footwear sector the geographical spread of country under CLE is divided in 5 regions i.e. Northern, Western, Central, Eastern and Southern.
