Subject- Removal of unauthorized store (PWD B&R) from the green belt at Old Industrial area, Bahadurgarh.

Respected Ma'am,

This is in reference to the HSIIDC letter sent to the Deputy Commissioner, Jhajjar, with reference number- HSIIDC/IE/BG/2023/6027 dated- 27/01/2023 (enclosed).

In reference to the subject cited above, it is to bring into your kind notice that in the green belt of the Old industrial area, Bahadurgarh adjacent to Rohtak- Delhi Road, there exist, a store and staff quarters constructed by PWD B&R. HSIIDC has made various correspondence with PWD B&R to remove the unauthorised store (reference of the correspondence given in the enclosed letter) but no concrete reply has been received from PWD B&R till date.

Respected Ma'am, with due respect, we request you to that with continuous follow-ups, take a strict action against this matter and get this resolved at the earliest as due to these unauthorised stores many upgradations in the Old Industrial Area, Bahadurgarh are pending.

Sub. Removal of unauthorized store (PWD B&R) from the green belt at Old Industrial Area Bahadurgarh.

R/Sir.

In reference to subject cited above it is to inform your goodself that Old Industrial Bahadurgarh was transferred by Industries & committee department, Haryana to HSIIDC in 2012. In its green belt adjacent to Rohtak Delhi Road there exists a store and staff quarter constructed by PWD B&R (location earmarked on layout plan). This office has made various correspondence with PWD B&R to remove the unauthorized store vide letters no. 799 dt. 13.10.2017, 1483 dt. 26.03.2018, 837 dt. 20.09.2018, 101 dt. 25.04.2019, 1327 dt. 06.01.2022, 1979 dt. 27.07.2022, 3091 dt. 14.10.2022 (copy enclosed annexure-I), but till date no concrete reply has been received from PWD B&R.

Industrial Association of this area had raised this issue in the meeting held at Ganpati Dham on 19.07.2022 under the chairmanship of Hon'ble Development & Panchayat Minister Sh. Devender Babli, regarding demolition of existing store in the green belt and also requested to grant access from the Old Industrial to main Rohtak-Delhi road through green belt with a reason that heavy vehicles cannot move smoothly on one side road towards civil hospital as another road is encroached by PHED Bahadurgarh. Hence, a connecting road through the green belt will make access for the commercial vehicles with main road.

Further, it is pertinent to mention here that Director, Industries & Commerce, Haryana has approved the proposal for creating a connecting road (40 ft. wide & 170 ft. length) through this green belt vide memo no. Exp/Bahadurgarh Industrial Association/23403-A dated 01.12.2017 (copy enclosed at annexure-II). An estimate amounting to Rs. 14.76 Cr. was also approved under SIID Scheme by the 21st meeting of State Industrial Infrastructure development Committee (SIIDC) held on 12.07.2018 under the Chairmanship of Chief Secretary Haryana wherein the provision of connecting road is also included in the estimate.

Competent Authority at the level of Head Office, HSIIDC has also approved the estimate amounting to Rs. 748.40 lacs has (including proposed 40 ft. wide road) for the work of up-gradation of Infrastructure at Old Industrial Area, Bahadurgarh. Since, the proposed road is passing through the green belt, so in view of the above, your good office is requested to direct the official of PWD (B&R) to remove the unauthorized store and grant permission to connect the proposed road with main road of PWD (B&R).
