Subject: Urgent Action Required to Address Law and Order Concerns in Industrial Areas of Bahadurgarh

Respected Sir,

We are writing to bring to your attention several critical law and order issues that are significantly impacting the safety and productivity of industrialists and workers in Bahadurgarh. It is imperative to establish a safe and secure environment to foster industrial growth and protect the well-being of industrialists as well as their workers.

We would like to highlight the following major concerns:

- Traffic Congestion at Tikri Border: The persistent traffic congestion at Tikri Border, particularly during peak hours, causes severe inconvenience and wastage of time for commuters, including industrial workers.
- Illegal Passage of Trucks and Trolleys: Many trucks and trolleys illegally pass through Mama Chowk, MIE Part-B, and cross the border to avoid tolls, resulting in traffic jams and damage to internal roads.
- Prostitution Activities in MIE Part-B: There has been a noticeable increase in prostitution activities near the Nala in MIE Part-B, adversely affecting nearby industries.
- Rise in Theft Cases: Incidents of theft have risen sharply in MIE Part-A & B industrial areas in recent months, necessitating increased patrolling to deter such criminal
- Traffic Issues near JJ Hospital: The road cut in front of JJ Hospital contributes significantly to traffic congestion, and we urge for its closure to alleviate this problem.
- Peak Hour Jams at Sector-6 Mod and near Sankhol Cut: Heavy traffic congestion is experienced during peak hours at Sector-6 Mod and near Sankhol cut, affecting industrial operations and worker commute.
- Jams due to Road Cuts: Road cuts at Civil Hospital, Bahadurgarh, and Bikaner Chowk, Sector-6, also contribute to traffic jams and require closure for better traffic
- Safety of Female Workers: More then 3-0-40% workers in majority of the industries are female. For the sake of their safety especially during evening hours, enhanced
